- The Responsible Jewelery Council (RJC) is an organization with regulatory tasks set up to promote ethically, human, social and environmental responsible practices across the entire diamond, gold and platinum chain. -

RJC has developed a reference standard for the precious metals and diamonds chain and a credible mechanism for ascertaining responsible operating practices through third party verification.

- The management of our company has appointed a contact person in order to monitor and record potentially significant problems as soon as they occur, checking that the policy is reflected in the strategies and operating procedures necessary to integrate it into all the company's activities.

GORGOGLIONE SRL has drafted and adopts this policy in order to document its commitment to use responsible practices, requiring the support of its employees and all the subjects that revolve around the company's activities.

The principles applied in GORGOGLIONE SRL are those related to both sustainable corporate growth and for the purposes of policies related to work, the environment, health and safety of people.

The intentions of GORGOGLIONE SRL are to apply the COP RJC for both the internal and external context. - 2. review this policy when reviewing the system and evaluating company performance;

- 4. communicate these objectives and the results obtained internally and externally to the identified stakeholders;
- 5. Adopt the Code of Procedure issued by the Responsible Jewelery Council and its subsequent updates or modifications, undertaking to apply the responsible business practices contained in the Code of Procedure.
- 6. Respect the principles and intentions stated in this document;
- 7. Apply the declared principles and intentions to the overall activity of GORGOGLIONE SRL;
- 8. Raise awareness and try to develop the skills of their collaborators with the aim of helping them to integrate programmatic policy into their work and procedures.
